Legislative Update

Eminent Domain Reform

HB 901 vs. HB 2730

HB 901: Relating to the acquisition of real property by an entity with eminent domain authority.

Rep. Burns, DeWayne (R)

HB 901 was discussed in the House Committee on Land and Resource Management on Tuesday, March 30. TFB President Russell Boening and several members of the Board, along with other county leaders, spent the day in Austin to personally testify in support of HB 901.

HB 2730: Relating to the acquisition of real property by an entity with eminent domain authority.

Condemnation & Property Taxes

HB 2043 and **SB 725**: Relating to the qualification of land for appraisal for ad valorem tax purposes as agricultural land and the liability for the additional tax imposed on such land if the use of the land changes as a result of a condemnation. Rep. Leman, Ben (R)

Sen. Schwertner, Charles (R)

On Tuesday, March 30, the committee substitute for HB 2043 was voted favorably from the House Committee on Land and Resource Management.

Simultaneously, SB 725 was heard on Monday, March 29, in the Senate Committee on Local Government. The bill was left pending.

Water

SB 601: Relating to the creation and activities of the Texas Produced Water Consortium.

On Tuesday, March 30, SB 601 was passed to the third reading by the Texas Senate with 31 votes *for* and 0 votes *against*.

A house companion to SB 601 was filed by Rep. Dustin Burrows (R). <u>HB 3096</u> was referred to the House Committee on Natural Resources.

Rural Connectivity

HB 5: Relating to expansion of broadband services to certain areas. Rep. Ashby, Trent (R)

High-Speed Rail

HB 3312: Relating to the disposition of real property acquired for high-speed rail projects.

Rep. Harris, Cody (R)

Summary

On Tuesday, March 30, the House Committee on Land and Resource Management heard public testimony on HB 3312.

HB 3312 would require that any land acquired for a high-speed rail (HSR) project could only be used for that purpose. The bill would also require that acquired land be offered back to the seller, or their successor, if the HSR project is canceled.

HB 3633: Relating to to establishing a High-Speed Rail Legislative Review Committee.

Rep. Leman, Ben (R)

Summary

On Tuesday, March 30, the House Committee on Land and Resource Management heard public testimony on HB 3633.

The bill would establish a thorough vetting process by which the Legislature would review each high-speed rail (HSR) project separately and determine whether or not the project would be granted the power of eminent domain.

To begin the process an HSR project entity would have to submit an application that would be reviewed by an HSR Review Committee of six legislators: The Lt. Governor would appoint three senators (one rural, one urban, one other). The Speaker would appoint three representatives (same breakdown). The Lt. Gov and Speaker would each designate one appointee that would serve as "co-chairs."

If the review committee found the application to be of merit, the committee would then make a recommendation to the Legislature for the re-establishment of the Texas HSR Authority, which was abolished in 1995, to decide on granting of a "franchise" to a HSR entity, allowing them the power of eminent domain.

Crop Health

HB 2089 and **SB 731**: Relating to the detection and mitigation of plant pests and diseases.

HB 2089 was referred to the House Committee on Agriculture and Livestock. The committee held a public hearing on HB 2089 last week.

SB 731 was referred to the Senate Committee on Water, Agriculture, and Rural Affairs.
