# Texas Farm Bureau Agriculture in the Classroom Outstanding Teacher Award Deadline: Friday, October 7 at 5 p.m.

### What is Ag in the Classroom?

Food, fiber, feed, and fuel. That's what agriculture produces. Food is one of the last shared experiences of every member of the human race. Not only is it essential that society understands food & fiber production, it is also the perfect experience to give meaning to educational concepts, because every student is familiar with food and clothing. Agriculture offers context to the content.

Ag in the Classroom is a multifaceted approach to increase agricultural literacy across the state. Texas Farm Bureau wants to recognize and reward those teachers who go above and beyond in the classroom to increase the agricultural literacy of their students.

### The Award -

One award will be presented to a classroom teacher for their creative efforts to teach students about the importance of agriculture. Teachers must utilize agricultural information and/or materials within their classroom curriculum. Learning activities may include, but are not limited to, an understanding of agriculture's impact on personal lives, our national heritage, the environment, our national security, and the economy. Innovative and interdisciplinary programs are encouraged.

### Eligibility –

- Certified PK-12 classroom teachers who actively teach about agriculture
- Any content area is acceptable, with the exception of vocational agriculture
- Previous winners of the award are not eligible; however, teachers who have previously applied but weren't selected are encouraged to apply again

### Selection -

All nominations will be evaluated by a panel of judges familiar with agriculture, education, and Agriculture in the Classroom. Judges may include one or more county Farm Bureau representatives; however, judges will not be selected from counties that have submitted a nomination.

### Prizes –

The winning teacher will receive:

- \$600 cash award
- Expenses paid to the 2022 Texas Farm Bureau Annual Meeting in early December
   \*Please note attendance at the TFB Annual Meeting is mandatory to receive the award
- Expenses paid to the 2023 National Ag in the Classroom Conference (Details TBA)
- Nomination for the National Ag in the Classroom Excellence in Teaching About Agriculture award

The county that nominates the winning teacher will receive:

- \$400 cash award
- Recognition on stage with the winning teacher at the TFB Annual Meeting

### Submission -

- Each county Farm Bureau may nominate one teacher.
- **Deadline for applications (including nominations) is October 7, at 5 p.m.**. County Farm Bureaus and applicants will be notified of judges' decision after October 25, 2022.
