PURPOSE

Recognize young farmers/ranchers for their achievements in production agriculture and leadership.

BACKGROUND

Texas Farm Bureau (TFB) annually conducts an Outstanding Young Farmer & Rancher (YF&R) Contest. Selection of the winning Outstanding YF&R competitor is based on his/her efforts in production agriculture and leadership achievement. Participation in this program with individual recognition and the resulting publicity will help build the individual and the organization. The ideal candidate(s) for the Outstanding YF&R Award is an individual or couple involved in production agriculture with a majority of his/her gross income subject to normal production risks.

All information provided within this application is handled in strict confidence.

2024 RULES & AWARDS - TEXAS FARM BUREAU COMPETITION ELIGIBILITY

An applicant can be either an individual or a couple that is married or has similar legal rights under the law. Applicant may choose to apply individually, rather than as a couple.

Applicant(s) must be a current member of Texas Farm Bureau. Married applicants will apply as a couple if both spouses meet all other eligibility requirements.

Applicant(s) shall be Texas Farm Bureau member(s) between the ages of 18 and 35 in good standing with his/her county Farm Bureau. The individual or spouse shall have reached his/her 18th birthday at the time he/she qualifies for the national competition and shall not have reached his/her 36th birthday by Jan. 22, 2025.

Applicant(s) must be actively engaged in farming and/or ranching, with the majority of his/her gross income coming from production agriculture.

Applicant(s) may compete in the Excellence in Agriculture or the Outstanding YF&R, but not both.

There is no limit on the number of entries from each county.

- Each applicant must use the Texas Farm Bureau online form and application located: http://bit.ly/TFB-YFR
- Past and present members of the AFBF Young Farmer & Rancher Committee and/or their spouse are not eligible to compete.
- Past state Outstanding YF&R Award winners are not eligible to compete.
- Current employees or agents of county, state and/or the American Farm Bureau organizations and their affiliates are not eligible to compete. An affiliate is defined as an entity owned or controlled in whole or in part by another entity through, for example, ownership (including partial ownership) or positions on the board of directors. Past employees and interns who were responsible for implementing any of the YF&R Competitive Events since January 1, 2018, at the state or national level are ineligible.

ENTRY FORM & APPLICATION GUIDELINES

Do not use applicant's name, the name of his/her state or county, or any names that may bring about the recognition or identification of the applicant's city/county beyond the entry form. The written versions of the application have a search feature to locate any identifiers.

The entry form and application must be completed in first-person narrative (i.e., I, me, we, etc.) for questions 1-8 and 12. 'A1' / 'A2' may not be used for questions 1-8.

Applicants must use 'A1' / 'A2' to denote each applicant for all of questions 9-11.

Do not use abbreviations or acronyms unless it has been spelled out once with the abbreviation in parentheses behind it. (For example, United States Department of Education (USDE). AFBF, FB, and YF&R are acceptable to use throughout the application.

It will be up to the discretion to deduct points if applicants include activities before they were 18.

PHOTOGRAPHS

Applicant may provide up to four (4) pictures of the operation, and one (1) family photo. The 4 operation pictures should not identify the applicant, or his/her city or county.

Pictures will need to be: 1200 pixels wide x 1600 pixels tall (4 x 6, 300 dpi) in jpg file format.

DEADLINE

The application must be submitted by selecting the green 'Submit and Finish' button on the online application no later than **11:59 p.m., August 2, 2024**. Once the application has been submitted you cannot edit your application.

NOTE: DISREGARDING ANY OF THE GUIDELINES LISTED ABOVE WILL RESULT IN DISQUALIFICATION.

JUDGING PROCESS

The entry form and application of each entry will be coded upon receipt by Texas Farm Bureau. The applicant's name and county will not be revealed to the judges until judging is completed.

ROUND 1 JUDGING

A panel of three qualified judges will review the written applications and will rank each. Judges scores will be tallied to determine the top eight applications. The top three ranked applications will be selected as the top three finalists.

FINAL ROUND JUDGING (THREE FINALISTS)

An additional panel of three qualified judges will review the top three state finalist applications and will visit each state finalist on their farm and/or ranch. From this process, the overall winner will be determined. The on-farm/ranch interviews will be up to 3 hours in length. During the visit/interview process, only the named applicant(s) on the entry form are permitted.

PRIZES AND AWARDS

The Outstanding YF&R Contest recognizes young farmers and ranchers who are actively engaged in farming and ranching.

This year, the top eight finalists will be selected from across all TFB districts. Of those top eight, three state finalists are selected. A panel of judges will visit each of the three finalists' farm or ranch to determine the overall winner.

- Expense paid trips to TFB Annual Meeting and AFBF Annual Convention

Two State Finalists:

- \$500 cash award
- Engraved acrylic award

- \$1,000 cash award
- Engraved crystal award

AFBF NATIONAL AWARDS

The AFBF Achievement Awards prize package will be published at a later date.
