# Water

**HB 4433:** Relating to the requirements for obtaining an interbasin water transfer permit.

# **Summary:**

HB 4433 strengthens the permitting process for transferring water between river basins in Texas by ensuring that any basin receiving transferred water has a clear need, alternative options have been considered, and conservation measures are in place. The bill also requires detailed reporting on water pricing, transportation costs, and environmental impact before a permit is approved.

These measures increase accountability and prevent unnecessary water diversions. It also ensures that water conservation efforts are in place before taking water from rural areas.

**HB 5348:** Relating to acquiring real property interests for environmental mitigation required for water projects.

#### **Summary:**

HB 5348 amends current law to provide greater protection for landowners whose land may be targeted for environmental mitigation associated with a water supply project.

Current law mandates that if a reservoir developer is required to offset environmental impacts, the developer must first offer to voluntarily pay a landowner for an easement rather than purchasing the land outright. Under current law, the landowner may reject the offer.

HB 5348 expands that requirement to all water supply projects.

The bill also mandates that if the entity did not utilize an easement for mitigation, they must submit an explanatory report to the Texas Water Development Board detailing why an easement was not employed.

This legislation provides greater protection of private property rights by giving landowners an option to retain ownership and use of their land.

# **Transportation**

<u>HB 4164</u> & <u>SB 2513</u>: Relating to notice requirements on state highway projects. <u>Guillen, Ryan</u> / <u>West, Royce</u>

### **Summary:**

Currently, TxDOT sends out a notice by mail to all potential landowners that may be affected by a project. HB 4164 and SB 2513 would require TxDOT to notify landowners in person if the department does not receive a response within 60 days from the date of the initial mailed notice.

This ensures landowners are notified of projects that may affect their land.

# TFB supports HB 4164 and SB 2513.

#### **Animal Care**

<u>HB 4167:</u> Relating to livestock brand registration expiration. <u>Guillen, Ryan</u>

#### **Summary:**

HB 4167 requires a county clerk to mail a notice to livestock owners 60 days before a brand registration expires.

This change is designed to assist livestock owners in managing their brand registrations effectively and prevent a lapse that could occur due to unawareness of impending expiration dates.

#### **TFB supports HB 4167.**

# **Property Rights**

<u>SB 2970:</u> Relating to the Texas Farm and Ranch Lands Conservation Program. <u>Hinojosa, Adam</u>

## **Summary:**

SB 2970 is a companion bill to <u>HB 2018</u> by <u>Rep. Trent Ashby</u> that was covered in a previous edition of the <u>Austin Newsletter</u>. The language is identical.

SB 2970 and HB 2018 ensures that agriculture conservation easements supported by the program will have provisions that enable landowners to continue agricultural use of the land.

It also puts more of an emphasis on supporting agricultural conservation easements that conserve productive farm and ranch land. These changes will ensure clear direction on the purpose of the program to keep land in agricultural production.

**HJR 7:** Proposing a constitutional amendment to dedicate a portion of the revenue derived from state sales and use taxes to the Texas water fund.
