I acknowledge that these risks may result from or be compounded by the actions, omissions, or negligence of Texas Farm Bureau (the "Company") or others not under the control or direction of the Company, including negligent emergency response, rescue operations, or medical treatment. I understand that the Company cannot guarantee that my child will not become injured or ill due to my child's participation in an Event and that engaging in an Event may increase my child's risk of becoming injured or ill. I give permission for my child to be treated at a local medical facility, if necessary for emergency medical care, and I understand that the cost of any medical treatment will be at my expense. Notwithstanding these risks, I acknowledge that I am voluntarily allowing my child to participate in the Events with knowledge of the dangers involved.

I consent to the use of photographs or other likenesses of my child in all media for purposes of publicity and promotion of the Events and release the Company for liability related to its use, alteration or republication of any such photographs or other likenesses.
